- 6.3. All proposals must be received by the submission deadline in Section 3.2 above. Late proposals will not be considered. All proposals received by the submission deadline will be evaluated by a team of three or more evaluators in accordance with the evaluation criteria stated in this RfP. No other criteria will be used to evaluate proposals. The contract will be awarded to the bidder whose proposal received the highest Total Score. IUCN does, however, reserve the right to cancel the procurement and not award a contract at all.
- 6.4. IUCN will contact the bidder with the highest-scoring proposal to finalise the contract. We will contact unsuccessful bidders after the contract has been awarded and provide detailed feedback. The timetable in Section 3.1 gives an estimate of when we expect to have completed the contract award, but this date may change depending on how long the evaluation of proposals takes.

# Background of the project:

IUCN, International Union for Conservation of Nature, is the world's largest and most diverse environmental network. IUCN's work focuses on valuing and conserving nature, ensuring effective and equitable governance of its use, and deploying nature-based solutions to global challenges in climate, food and development. In 2014, IUCN became an accredited Project Agency of the Global Environment Facility (GEF).

The GEF funded Blue and Green Islands Integrated Program is one of 11 integrated programs formulated under the GEF 8 programmatic directions. The overall Program Objective of the Integrated Program whose development is led by UNDP is to "Move towards an Equitable, Nature-positive, Carbon neutral and pollution free world". The programme will be focusing on three broad areas to advance transformational systems regionally and globally.

The Republic of Palau's project, "Transforming productivity in Palau's food systems through nature positive innovations" child project EOI with IUCN as the GEF Agency was selected by GEF Secretariat to be funded under the GEF 8 Blue Green Islands integrated program.

The project aligns directly to the BGI's two main components of integrating nature into fiscal policies (for food systems) and implementation of Nature-based Solutions at landscape and seascape levels while supporting transformation of Palau's food systems with support from the tourism industry. This

IUCN/SPREP/SPC-led Communities of Practice, that will facilitate the exchange of information and best practices among stakeholders. This system will include tools such as peer-to-peer learning exchanges, workshops, and training sessions, as well as an online platform for sharing information and resources. This will align with the SIDS Nature-Based Solutions Accelerator and SIDS Private Sector & Finance Facility (PS&FF) to ensure learning from NbS implementation in FSM can be harnessed for replication and scaling.

This project will be funded through the Blue Green Islands Integrated Program and biodiversity / land degradation focal areas of the GEF, up to USD 6,000,000 STAR allocation with USD 2,000, 000 IP incentive and is expected to mobilize USD 11,700,000 in co-financing. The project preparation grant (PPG) available for this project is up to USD 200,000. The approved project is presently in the form of a draft concept note and can be shared upon request.
